

## U3A Colac Otway Inc. Privacy Policy

### Introduction

U3A Colac Otway recognises the importance of protecting members' privacy in relation to their personal information.

### Purpose

The purpose of this policy is to set out members' privacy rights and to document the framework that U3A Colac Otway will apply when collecting, storing and using members' personal information.

### Policy

1. This policy applies to any information collected by U3A Colac Otway that can be used to identify an individual member. We may collect and record the following types of personal information about members:

Name

Postal, street and/or email addresses

Telephone contact number/s

Previous profession or occupation

Skills or interests

Emergency contact details

Image (photo or video)

Other information you provide to us through member surveys or for other purposes

2. U3A Colac Otway will collect personal information about each member directly from the member in question. This will be done through membership and course registration processes. Approval to use a member's image/s in U3A Colac Otway publications will be sought on the *Membership Application* form; members who decline to permit use of their image will be required to opt out of U3A Colac Otway photographs. From time to time, other information may be collected via a survey or by other methods.

3. U3A Colac Otway collects personal information from members so that we can provide services and perform functions that are consistent with our constitution, including:

To make classes and other activities available to members

For communication, administrative, marketing, and planning purposes

For program development, quality control and research purposes

To maintain accurate and up-to-date membership records

4. U3A Colac Otway will:

Only collect information that is consistent with our primary purpose and constitution.

5. Inform members of the reason why information is collected and how it is administered

6. Inform members that any personal information held about them is accessible to them.
7. Take all reasonable steps to ensure that personal information held is accurate and up-to-date
8. Take all reasonable steps to ensure that personal information held is protected from misuse, loss and unauthorised access
9. Members' personal information will not be shared or disclosed other than as described in this policy. Personal information will not be made available to others for direct marketing purposes.
10. U3A Colac Otway may disclose your personal information, for purposes that are directly relevant to our constitution, to: Office Volunteers, for example, activity leaders and members of the Committee of Management.
11. As our website is linked to the internet, and the internet is inherently insecure, we cannot provide any assurance regarding the security of transmission of information you communicate to us online and these communications will be at members' own risk.

### Procedures

1. Members may request access to any personal information U3A Colac Otway holds about them by contacting U3A Colac Otway's Membership Coordinator who will aim to provide a suitable means of accessing the information.
2. Where a member believes that personal information held about him/her is incomplete or inaccurate the member may ask the Membership Officer to amend it.
3. Where a member believes their privacy has been breached, they should contact U3A Colac Otway's Secretary and provide details of the incident so that it can be investigated.
4. Any questions or concerns about this policy, or a complaint regarding the treatment of personal information, should be referred to U3A Colac Otway's Secretary.
5. U3A Colac Otway will treat confidentially all requests or complaints lodged regarding this policy. We will contact you within a reasonable time after receipt of your complaint to discuss your concerns and to outline options regarding how they may be resolved. We will aim to ensure that your complaint is resolved in a timely, impartial and appropriate manner.

### Responsibilities

U3A Colac Otway's **Committee of Management** is responsible for:

- a. Developing, adopting, implementing and publishing this policy
- b. Collecting, storing, using & disposing of members' personal information in accordance with this policy
- c. Membership forms will be destroyed of after 3 years.
- d. Investigating complaints about the handling of personal information
- e. Approving access to personal information consistent with this policy
- f. Monitoring and revising this policy as and when the need arises.

U3A Colac Otway's **Secretary** is responsible for: receiving enquiries about this policy and complaints about a potential breach of this policy; and, for bringing a complaint before the Committee of Management for investigation and resolution.

U3A Colac Otway's **Membership Coordinator** is responsible for responding to a member's request for access to the personal information held by U3A Colac Otway about that member and for requests to correct personal information that is believed to be inaccurate or out of date.

### **Authorisation**

This policy has been written in compliance with the Privacy & Data Protection act 2014.

This policy was adopted by Committee of Management of U3A Colac Otway Incorporated as minuted 10<sup>th</sup> August 2021.
